2. ABOUT PROSPERO LIMITED

The Manager will collaborate across the organisation to identify and implement initiatives wherever possible.

3. SPECIFIC CONTEXT OF THE ROLE

The specific context for this role is:

The job exists to perform the following major functions:

- To lead the design of the sector strategy with the guidance of the Pipeline Development Lead
- To effectively support delivery of the pipeline development initiative by identifying SMEs and developing, managing, and delivering relevant intervention partnerships; and
- Collaborate closely with the Pipeline Development Lead in adapting/developing current and new initiative strategies.
- To support monitoring and administration of all intervention partnerships and strategic partnerships

4. SCOPE OF WORK

The specific duties of the position are as follows:

Sector Strategy and Delivery

- Provide technical support to SMEs through coaching, mentoring, and training to enhance SME skills helping them to become more attractive to investment in close collaboration with the Investment Services Initiative.
- Support SMEs linkage to finance and growth capital through sustainable market connections, grant and investment opportunities.
- Collaborate with the Prospero Pipeline Enabling Initiative and other initiatives in identifying and scoping SMEs.
- Lead development of initiative strategies, budgets and workplans with technical proficiency to support Zambian SMEs' access investment in the future.
- Identify systemic market constraints within the initiative and identify SMEs or service providers who can develop appropriate interventions or solutions.
- Critically review and assess grant proposals, budgets, SME delivery capacity and financial management capacity
- Identify and work closely with consultants, as necessary, to support the implementation of interventions.
- Ensure that all interventions provide value for money and reach the maximum possible number of MSMEs.
- Contribute to new business development opportunities by identifying new business leads and contributing to proposal writing.

• Lead the design and implementation of training and coaching materials on agriculture related topics and business management for technical support to SMEs.

SME Engagement

- Lead development, engagement, relationship building and management of SMEs that are critical to delivering the initiative strategy.
- Continually stay abreast of project implementation and progress, helping to creatively troubleshoot issues as (and before) they arise to ensure partner momentum.
- Support partners with development of concept notes, project proposals, budgets, cashflows, workplans and implementation.
- Where necessary, identify gaps in partner delivery and financial capacity that would benefit from extra support and develop appropriate solutions.
- Where necessary, support design and implementation of performance monitoring systems and tools to ensure partners can stay on track.
- In conjunction with the Monitoring and Evaluation team, ensure all regular reporting for sector initiatives by any intervention partners is completed and submitted accurately and on time.

Stakeholder Coordination

- Actively lead engagement, coordination, where possible, identify opportunities for collaboration (such as steering committees, stakeholder boards or consortia) with partners and other stakeholders (including donor projects) working within the initiative.
- When necessary, proficiently speak about Prospero and relevant initiatives in meetings, events, or workshops.
- Maintain and build Prospero credibility and reputation within relevant sectors.
- Build relationships and networks with potential funders.

Administration and Internal Coordination

- Administrative duties related to implementation of chosen interventions and activities (Terms of Reference development, development of grant concepts/proposals, organisation of workshops/trainings, due diligence support, etc.)
